

**FL-501 - FY2022 HUD Special CoC Program Competition - Notice to Project Applicants  
Project Inclusion / Exclusion List with Project Scores and Project Priority Listing Placement**

The Tampa Hillsborough Homeless Initiative (THHI), as the lead agency and collaborative applicant for the Tampa/Hillsborough County CoC, hereby issues, on **October 26, 2022**, the Notice to Project Applicants of Inclusion / Exclusion for the FY2022 HUD Special CoC Program Competition NOFO Application.

This Notice Includes all new and expanded projects submitted in response to the CoC's Universal Request for Proposal (RFP) in accordance with the CoC Universal RFP process that were reviewed for inclusion in the FY2022 HUD Special CoC NOFO Application. Per the Universal RFP process, projects submitted in response to an RFP that is conditionally award and/or awarded funding maybe be considered for other funding opportunities (such as this HUD Special NOFO) that were not known about at time of the annual Universal RFP.

The applications (Project Proposals and Letters of Continued Interest) for the 2022 Universal RFP were submitted to the CoC on May 17, 2022.
